Facility security

All visitors are required to enter through the front lobby of the administration building. Prior to entering the facility, each visitor must sign in at administration lobby. All visitors will obtain a visitor badge to be conspicuously worn or available for verification at all times during the visit. Please review the evacuation plan to identify the nearest exits in case of an emergency.

Emergencies

If you encounter an emergency situation (e.g. a fire, gas leak, tornado, terrorist threat, or healthcare emergency) please dial 281-290-5100 or x5100 from any phone in the facility. This emergency line is monitored 24 hours a day, 7 days a week by security personnel. Your call will activate the emergency response system. Please be prepared to report the nature of the emergency and the location from which you are calling.

Assembly areas (map on back)

There are three (3) assembly areas located throughout the facility. The locations of these assembly areas were selected to maximize the safety of employees and to assist in communications concerning the status of the emergency. When an evacuation occurs, proceed to the assembly area nearest you and await further

instructions. Do not re-enter the building until the "ALL CLEAR" (automated message on the emergency alarm system) is given. Do not drive a vehicle in the parking areas unless authorized to do so by emergency management personnel.

Severe weather alert

In the case of a tornado or other severe weather notice, the severe weather alarm will be sounded. You should stay with your escort and immediately go to the nearest designated shelter area. Remain there until the ALL CLEAR signal is given.

Harassment

Baker Hughes is committed to providing employees and others on the company premises with an environment free from illegal discrimination, including sexual harassment by anyone, including coworkers, supervisors, vendors, contractors, customers or any third party.

Personal protection

Approved eye protection with attached side shields is required in most manufacturing areas throughout the facility. Approved eye protection will be provided for visitors to the facility. Foot protection is also required in many areas. Open-toe or open-heel shoes are not

permitted in any area requiring foot protection. Personal protection requirements for infection control against COVID-19, and any associated variants, will be clearly signposted and any controls will be explained by your escort.

Prohibited material/equipment

The possession of alcoholic beverages, illegal drugs, explosives and/or firearms is strictly forbidden at the facility. Any visitor/guest suspected of being under the influence of drugs or alcohol will not be permitted entrance.

Safety data sheets

If your visit includes the introduction of any chemicals, they must be accompanied by a current Safety Data Sheet (SDS).

Chemical Safety Data Sheets for chemicals at the WHEC Center are available upon request from your facility sponsor or Baker Hughes representative.

Smoking

Baker Hughes policy prohibits the sale or use of tobacco (smoking and smokeless) and tobacco related (electronic cigarettes and vaporizers) on Baker Hughes owned property and portions that are leased.

Stay alert

Watch out for moving vehicles: forklifts, cars, trucks and golf carts. Assume the other driver does not see you and act accordingly. Maximum speed limit within this facility is 10 MPH. Reverse parking is required at all Baker Hughes facilities. Remember that pedestrians always have the right-of-way.

Cellular phone use

Cell phones and other electronic devices are prohibited while driving any motor vehicle or while operating moving equipment on Baker Hughes property. Check with your Baker Hughes representative before using your cell phone.
